Pool Pit Repair Proposals – The Board reviewed proposals for the pool pit repairs. Kevin Todd made a motion to approve the proposals provided by Palm Springs Leak Detection and The Pool Guy to relocate the pool equipment for a cost of \$23,000. Daniel Hawkins seconded the motion, all in favor, motion passed.

Rules & Regulations – The Board reviewed the draft Rules & Regulations. Kevin Todd made a motion to approve the Rules & Regulations contingent upon review by Delphi Law Group. Olwen Garcia seconded the motion, all in favor, motion passed.

Proposed Election Rules – The Board reviewed the draft Election Rules. Kevin Todd made a motion to approve the Election Rules. Olwen Garcia seconded the motion, all in favor, motion passed.

Annual Election – The Board discussed the vacant position on the Board. The Board agreed to leave the vacancy and not appoint a member to fill the vacated seat and wait to fill the position with the annual election.

Gas Meter Study – Kevin Todd provided a comparison of gas usage, December 2021 – June 2022 and December 2022 – June 2023.

Clubhouse Furniture – Kevin Todd made a motion to approve the purchase of clubhouse furniture for a cost of \$5,000. Daniel Hawkins seconded the motion, all in favor, motion passed.

Pest Control Renewal - The Board discussed renewal for building 8. The invoice was pending.

Entry Way Resurfacing Proposals – The Board reviewed one proposal. It was noted that this project will be addressed after the balcony and painting projects.

Fences/Gates & Rails Revised Proposal & Update – The Board reviewed a proposal for the fabrication and installation of 38 stairway railings. Kevin Todd made a motion to approve the proposal provided by Empire Works for a cost of \$153,200. Olwen Garcia seconded the motion, all in favor, motion passed.

Deck Repairs & Renovation Update - Revised proposal pending. No action taken at this time.

Bulk Services (Frontier & HotWire) - There was no report at this time.

### ARCHITECTURAL

Ratify Architectural Approval #229 – It was noted that the architectural modification request submitted by the owner of #229 for the replacement of the electrical sub panel.
